DECREE OF PRESIDENT OF THE REPUBLIC OF AZERBAIJAN

on amendments to some decrees and orders of President of the Republic of Azerbaijan with respect to application of the referendum act of the Republic of Azerbaijan on Additions and Amendments to the Constitution of the Republic of Azerbaijan as a result of the 18 March 2009 referendum
